## 3. LEGITIMATION AND DATA COLLECTED

### 3.1. Consent to process your data

### **4. SECURITY MEASURES**

### **6. RIGHTS OF THE USER**

The person in charge of the file will stop processing the data, except for compelling legitimate reasons, or the exercise or defense of possible claims.

In accordance with current legislation, you have the following rights: right to request access to your personal data, right to request its rectification or deletion, right to request the limitation of its treatment, right to object to the treatment, right to data portability and likewise, to revoke the consent granted. You also have the right to file a claim with the Spanish Data Protection Agency.
